DRAFT Minutes

Welcome

The meeting was called to order at 1:07 PM

Approve [April Meeting Minutes](#) and [May Meeting Minutes](#)

April and May meeting minutes were approved.

- Motion: Kate Willard - Second: Didi Pershouse - Vote: Approved

NRCS Updates

Privacy & Data Sharing (1619 Agreement)

- Discussion on whether a board member training on the 1619 data-sharing agreement would be helpful.
- NRCS contract details cannot be shared externally, but certain information can be used to report district activity to select boards.

Reporting to Select Boards

- It was mentioned that a town-by-town report showing funded conservation practices, amounts, and the agencies and programs involved (including non-federal sources such as Trees for Streams) could be helpful. Jaiel and Jen can work with other staff to put together.
- Vermont's EQIP allocations have grown to \$5.6 million, largely due to district outreach efforts.

NRCS Leadership Meeting

- Alvina and Jen met with Travis (NRCS) and two staff members. Travis expressed enthusiasm for the new NRCS leadership and indicated he anticipates increased conservation funding.
- Travis supports the Agriculture Guidance Document.

District Updates

- **VT NRCD Agriculture Staff Guidance Document Draft (JB 6.2.26)**

The board reviewed the VT NRCD Agriculture Staff Guidance Document (draft dated June 2, 2026). Key points:

- Purpose: To standardize agricultural staff work across districts, demonstrate to NRCS and the Agency of Agriculture how district funds are used, and provide a framework for holistic farm planning and team coordination.
- The document is primarily Vermont-specific and reflects state programs, including voluntary conservation programs that fund district staff.
- Developed collaboratively with Windham County, Heather Blunk, Kate Wintergreen, Sara (Orleans County), and Emily Newmer, with AGCWIP grant funding (two-year grants currently concluding).
- Vermont runs some of the most robust state-level voluntary conservation programs in the country; this document helps ensure those resources are not underutilized.

[Approval of public comments for the ANR Lands Management Planning Rule](#)

The board discussed the proposed ANR rule change for long-range management planning on state lands. Key discussion points:

- The rule aims to improve coordination among state agencies (ANR, Agency of Agriculture, and others) in public land planning.
- Board concerns: the rule's public engagement process does not adequately reflect Vermont's environmental justice requirements; proactive solicitation of comment on biodiversity, chemical use, wild-harvested products, and NRCC representation is needed.
- The board supports requiring an environmental impact assessment before significant land management actions and making chemical avoidance the first option considered in planning processes.
- Vote: The board approved submitting public comments with the district's name. Names to be added: Didi Pershouse, Alvina Harvey, Sabra Ewing, Kate Willard. Motion: Kate Willard. Second: Sabra Ewing. Vote: Approved

Lake Fairlee Shoreline Project

Horizons Bioengineering Project Review:

- Stuart from Horizons presented the completed Lake Fairlee shoreline bioengineering project, which removed an aging sea wall and restored a naturalized, ecologically sound shoreline.

- Project funded by DEC and the Aloha Foundation. Goals include improved lake health, increased biodiversity, and use as an educational demonstration site.
- A fall site visit for interested board members is being planned (when camp is not in session).

- **Upcoming Events:**

- Attend the June 26 Land Care Agriculture event (sign up via the agenda link).
- Meet with the Harvard Law School contact regarding support for the Public Banking Congress.
- Coordinate and deliver the September soil health training at VTSU, including food and housing arrangements.
- Review the Northern Border Regional Commission grant opportunity; send board contact information and funding category links.
- Follow up about the Northern Border Regional grant.
- Obtain the easement legal memo from Vermont Law School and share it with the board before the next meeting.
- Plan a future board meeting focused on easements and staff evaluations.
